Enrolment Requirements

Eligibility requires enrollment in an overseas university as an undergraduate or postgraduate student, proficiency in English, and pre-approval from the student's home institution.

Course Description:

This unit focuses on the principles of human ergonomics, industrial design, creativity, and problem-solving within a studio learning environment. Students will engage in team project work, marketing, and product development, collaborating with industry practitioners on the creative design of products for human use. The course covers the optimization of man-machine-environment systems, introducing basic concepts, theories, and methods in human factors engineering. Students will learn about the physiological and psychological characteristics of humans, their interactions with machines and environments, and the design of man-machine systems, interfaces, and workspaces. By the end of the course, students will be equipped with the skills to analyze, design, and improve man-machine systems effectively.

Prereauisite:

Prior knowledge in fundamental accounting is required for taking this course.
